

# Terms & Conditions

These Terms & Conditions (the "Agreement") are applicable to the: (i) web pages, (ii) services, (iii) content, (iv) databases and (v) information (collectively referred to as the "Services") together with the agreements and software provided by Fondexx Inc. ("Fondexx") to which you may have access by using Fondexx's website or, upon request, in hard copy. ## **Agreement**

By using the Services, you are confirming your consent to be bound by the terms of this Agreement.
